Subject | DECLARATION OF COMPLIANCE

Our company, Vetroelite, hereby certifies that:

- ✓ All silico-soda-lime glass containers delivered to our customers are classified in the 3rd hydrolytic class in accordance with Regulation 10/2011/CE and 12111 of May 1976 and "A" according to the Ministerial Decree of 21 March 1973 and subsequent amendments (Legislative Decree no. 108 of 25 January 1992 transposing EU Directives 89/109, Ministerial Decree no. 220 of 26 April 1993, Ministerial Decree no. 735 of 28 October 1994), and amended by the current Regulation 1935/2004 of the European Parliament and of the Council of 27 October 2004. This category includes all containers that may come into contact with foodstuffs under any conditions.
- ✓ The presence of heavy metals in the glass produced by our company complies with Directive 94/62/EC and following exceptions and with Legislative Decree no. 22 of 5 February 1997.
- ✓ The process of production and handling of containers is such that the presence of foreign bodies inside them can only be determined by accidental causes alien to the process itself.
- ✓ To avoid contamination, prevention techniques have been adopted to ensure the hygiene of containers for food products, in compliance with Regulation no. 2023/2006/EC.
- ✓ The containers supplied by our company are not sterilized.
- ✓ They comply with European Directive 94/62/EC "Packaging and Packaging Waste" transcribed into French law by decree 98/638 of 20 July 1998 and amended by European Directive 2004/12/EC of 11 February 2004.

These directives concern the taking into account of the needs related to the environment in the design and manufacture of packaging, in particular:

1 – To meet the essential requirements

- Glass composition of our packaging and nature of the surface treatment
- Glass articles designed to have the ideal weight, considering all obligations for use and production, following procedure UNI EN ISO 9001 and according to EN 13428.
- 100% recyclability of the glass
- Recyclable packaging tertiary serving the transportation of glass packaging (VMF wooden pallets, which are reusable and pentachlorophenol-free, without interlayers, covers, cardboard or plastic hoods, or ropes)

2 – The content of heavy metals and other harmful substances in the glass composition (decision of the European Commission no. 2001/171/EC of 8 May 2006)

In addition, they comply with Regulation no. 1935/2004 on the "Materials and Articles intended to come into contact with foodstuffs"

The compliance also covers all surface treatments applied to our glass containers.
